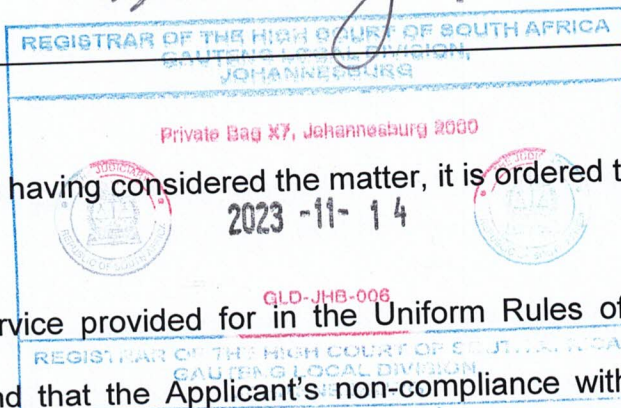

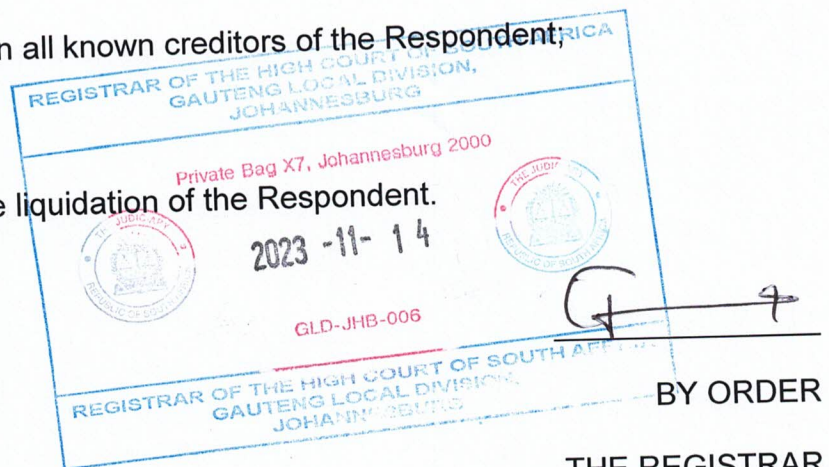
Having heard counsel and having considered the matter, it is ordered that:

1. The forms and service provided for in the Uniform Rules of the Court be dispensed with, and that the Applicant's non-compliance with the same be condoned, and that this application be enrolled, heard and determined as one of urgent as contemplated in Uniform Rule 6(12);
2. A rule nisi be issued, calling upon the Respondent and all interested parties to show cause, if any, on 19 February 2024 at 10:00, as to why:
  - 2.1. the provisional liquidation should not be made final;
  - 2.2. costs should not be costs in the liquidation of the Respondent.
3. Service of this order be affected:
  - 3.1. by the Sheriff on the Respondent;

- 3.2. by the Sheriff on the employees of the Respondent by affixing a copy thereof on the door to the main entrance to the premises of the Respondent situated at 50 Mandeville Road, Bryanston, Sandton, Johannesburg, 2191;
- 3.3. by the Sheriff on the Trade Unions of the Employees (if any);
- 3.4. by hand on the South African Revenue Service;
- 3.5. by hand on the Master of the High Court;
- 3.6. by publication in one English and one Afrikaans newspaper circulating in the area of the Respondent's registered address;
- 3.7. per email on all known creditors of the Respondent;
