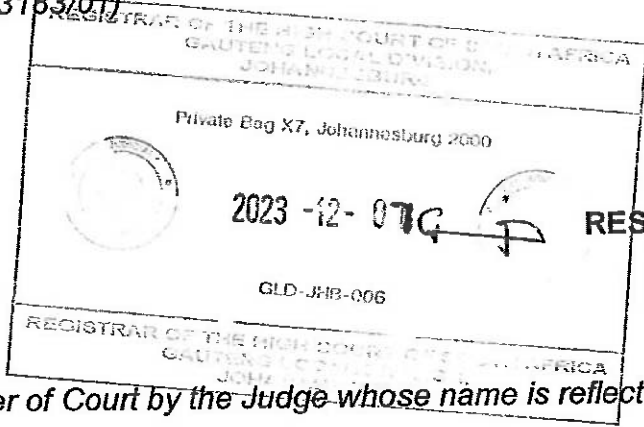

3. A *rule nisi* is issued, calling upon the Respondents and all interested parties to show cause, if any, on **29 February 2024 at 10:00**, as to why:

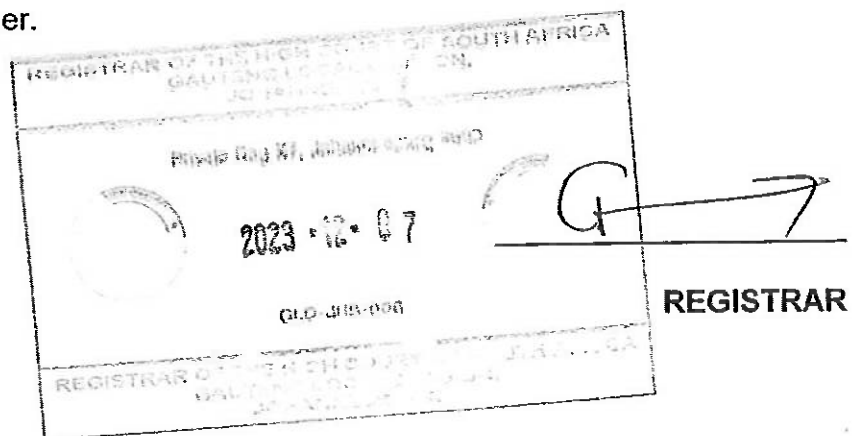
3.1 A final order of sequestration should not be granted; and
